Hungarian Association of Environmental Enterprises

The Hungarian Association of Environmental Enterprises (HAEE) is a non-profit advocacy organization, established in December, 1992.

At present, we have 230 member companies, which are important economic operators of the Hungarian eco-industry. The members of the Association observe and enforce the local, regional and global goals, principles and priorities of environment and nature protection. They promote protecting biodiversity, achieving the goals of climate policy, conserving natural resources, implementing circular economy, waste hierarchy, economical and effective usage of materials and energy, and sustainable development of livable environment. We help improve environmental processes and activities both at national and international level, with special regard to the Carpathian Basin, The Danube River Catchment Area and the V4 cooperation.

ADVOCACY

As a representative of professional interests, the Association is a valued expert partner of the national legislation preparatory bodies, and requests statutory interpretations and resolutions for the specific demands of its members.

FOCUS ON GREEN INDUSTRY

The members of the environmental industry directly contribute to protecting one of the fundamental citizens' rights, i.e. ensuring healthy environment, and also to achieving the national and UN sustainability goals. In accordance with that, our members do not only perform entrepreneurial activities, but also public functions. That added social value distinguishes them from the companies operating in other sectors, since the members of the environmental industry perform their tasks with increased social responsibility, broad spectrum of professional knowledge and innovative solutions, while also creating jobs. Our common activities contribute to sustainability, establishing green industry and green economy in Hungary, and implementing the concept of circular economy.



OUR WORKING GROUPS

The Association manages working groups with the participation of the representatives of its member companies to promote efficiency in the operation of the sector and the member companies. 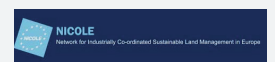
PROFESSIONAL EVENTS, CONFERENCES, EXHIBITIONS

- The HAEE regularly organizes conferences on the current issues of waste management, awareness-raising, remediation, environmental measurements and sampling, air quality protection, sewage sludge treatment and sewage management.
- The ÖKOINDUSTRIA International Environmental Industry, Energy Efficiency and Renewable Energy Exhibition is organized traditionally every second year by the Association. The 6th ÖKOINDUSTRIA Exhibition will take place in Budapest in April, 2020.
- Every February, we organize a National Environmental Protection Meeting with the participation of renowned agents of environmental protection and environmental industry, managers of diplomatic missions and member companies. At this prestigious event, The Awards for Environmental Protection, established by the HAEE, are given for two categories: private individuals and companies.
- We publish an EcoIndustry Yearbook online: a popular almanac of the Hungarian environment and nature protection (EcoIndustry Yearbook: evkonyv.kszgysz.hu).

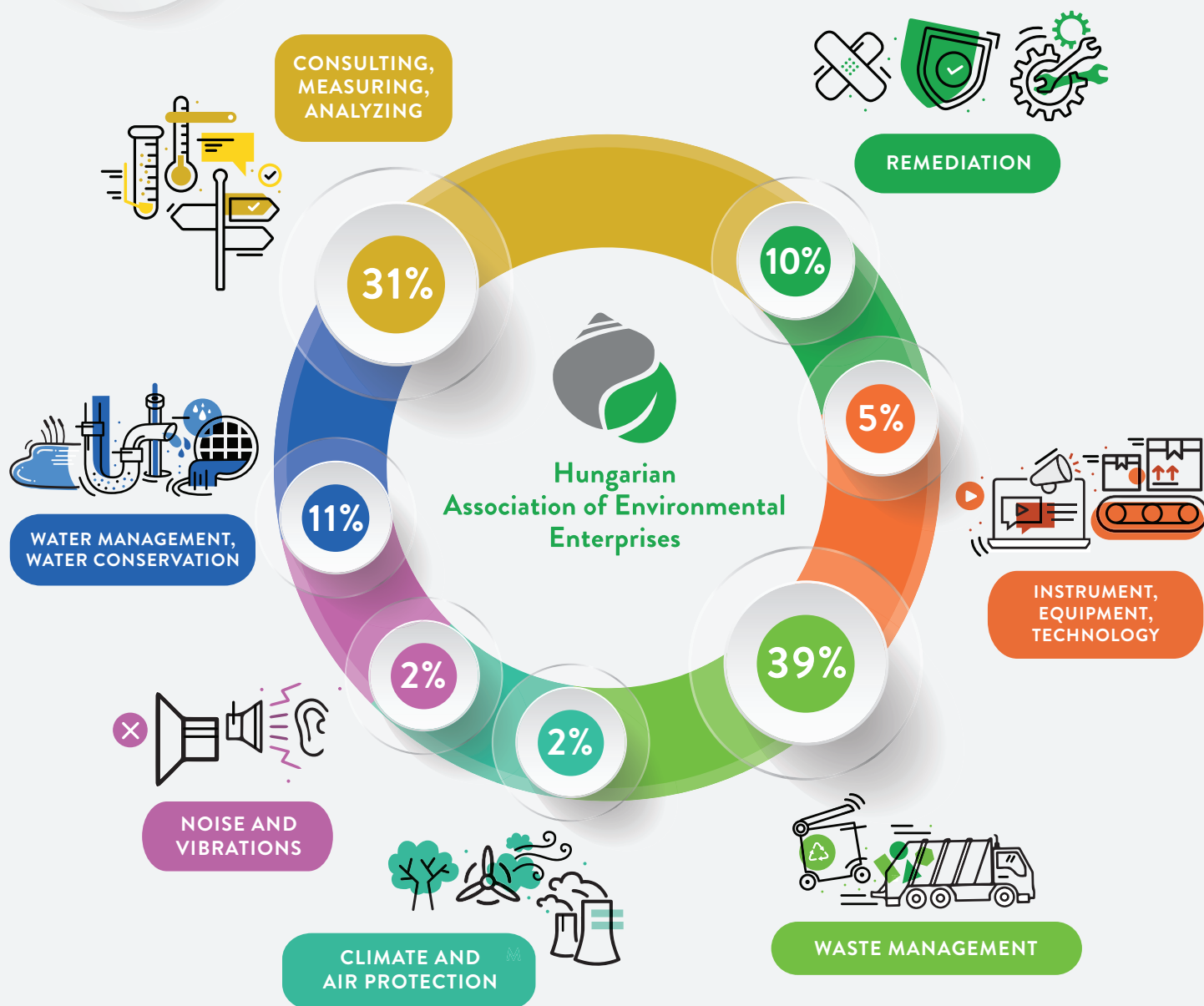

The cluster is open to every organization – not exclusively in the environmental industry – that has accreditation in Hungary or has officially requested it.

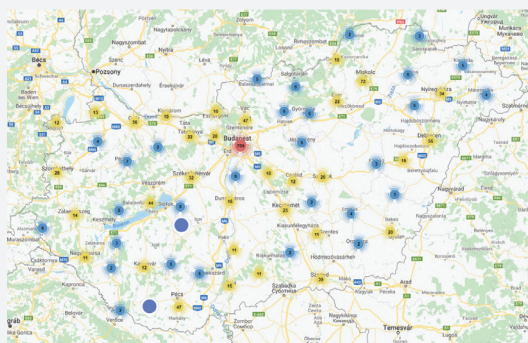
